MASTER OF ARTS IN THE FIELD OF **FORENSIC PSYCHOLOGY**

The master's program in forensic psychology addresses the justice system's critical need for professionals specializing in investigative psychology, criminal profiling, threat assessment, and evaluation and treatment of justice-involved individuals and victims of crime. Students in the program are dedicated to making a difference within the criminal justice system, whether working in law enforcement, homeland security, correctional systems, or organizations that provide services to justice involved individuals and victims of crime.

The program provides a strong foundation in the field of forensic psychology, and offers students the opportunity to complete courses and externship training opportunities tailored to their interests. In courses ranging from psychopathology to law, students examine the psychological underpinnings of human behavior for those involved in the legal system. They also explore current approaches and interventions for individuals dealing with mental illness and the methods and professional issues faced in investigative work, while learning techniques for successfully presenting expert testimony and advocating for at-risk individuals or populations. Day, evening and weekend classes are offered to accommodate both full-time students and working professionals.

ADMISSIONS

Admission deadlines:

Fall - Applications are reviewed on a rolling basis beginning in January, with a final deadline of April 1 (February 1 for fellowship consideration).

Spring - Applications are reviewed on a rolling basis beginning in August, with a final deadline of October

Applications submitted after the deadlines indicated above will be considered on a case-by-case basis.

Standardized GRE general test (institutional code 5246). Waived for test scores: applicants who hold a JD, MD, or PhD.

> The Test of English as a Foreign Language (TOEFL), the academic International English Language Testing System (IELTS), or the PTE Academic is required of all applicants except those who hold a bachelor's, master's, or doctoral degree from a college or university in the United States or from an institution located in a country in which English is the official language, provided English was the language of instruction.

Minimum scores for the program are:

- Academic IELTS: an overall band score of 6.0 with no individual score below 5.0; or
- TOEFL: 550 on paper-based or 80 on Internetbased; or

- PTE Academic: 53

If transcripts are in a language other than English, English language translations must be provided. The English translation alone should be uploaded into your application.

An interview is required for those applicants whose requirements application is deemed by the faculty to indicate a high probability of success in the program. Applicants for whom a personal interview would create an undue hardship may request that the interview be conducted telephonically.
