# DOCTOR OF PHILOSOPHY IN THE FIELD OF CLINICAL PSYCHOLOGY (STEM)

The PhD in clinical psychology program follows the scientistpractitioner model. In this American Psychological Associationaccredited program, students are trained as applied researchers and scientists, developing skills in the research methods used to advance knowledge of the causes, prevention, and treatment of emotional, behavioral, and physical health problems within diverse communities.

The program's coursework, research, and clinical training are grounded in developmental and social-ecological perspectives that attend to the intersection of multiple forms of diversity and recognize the impacts of systemic oppression on individuals and communities.

Faculty subscribe to a range of theoretical orientations, including cognitive-behavioral, family systems, social-ecological, and community frameworks. These perspectives enable students to develop a broad base of knowledge and the opportunity to specialize in particular areas of research and evidence-based application.

This is a STEM designated program.

# ADMISSIONS

Admission Fall: December 1 deadlines: Standardized GRE general test is not required. test scores:

> The Test of English as a Foreign Language (TOEFL), the academic International English Language Testing System (IELTS), or the PTE Academic is required of all applicants except those who hold a bachelor's, master's, or doctoral degree from a college or university in the United States or from an institution located in a country in which English is the official language, provided English was the language of instruction.

Minimum scores for the program are:

-Academic IELTS: an overall band score of 7.0 with no individual score below 6.0; or

-TOEFL: 600 on paper-based or 100 on Internetbased; or

-PTE Academic: 68;

Prerequisite Course prerequisites: applicants need to meet requirements program course requirements in one of three ways:

a) Have an undergraduate Bachelor's degree in psychology

### b) Have a Master's degree in psychology

c) For Non-Psychology majors - Complete at least six undergraduate or graduate courses in psychology, including Statistics, Research Methods, Abnormal Psychology, and three general content courses (such as developmental psychology, social psychology, cognitive psychology, personality, biological bases of behavior, or history and systems of psychology).

Prior academic records:

Transcripts are required from all colleges and universities attended, whether or not credit was earned, the program was completed, or the credit appears as transfer credit on another transcript. Unofficial transcripts from all colleges and universities attended must be uploaded to your online application. Official transcripts are required only of applicants who are offered admission. If transcripts are in a language other than English, English language translations must be provided. The English translation alone should be uploaded into your application.

Statement of In an essay of 500-1000 words, state your purpose

purpose: in undertaking graduate study in your chosen field. Include your academic objectives, research interests, research experience, and career plans. Describe how you see your role as a scientist-practitioner within the context of social justice and diversity considerations. In responding to this question, we encourage you to reflect upon how your cultural, ethnic, or personal background brings a unique perspective to the Clinical Psychology graduate program. ## REQUIREMENTS

The following requirements must be fulfilled:

72 credits, including 54 credits in required courses, at least 6 credits in dissertation courses, and 15 credits in dissertation or elective courses. Students also take five 0-credit courses and successfully complete a comprehensive examination.

In addition, students are required to obtain clinical training, including a minimum of two assessment practica and two therapy practica in the Meltzer Center (https:// psychology.columbian.gwu.edu/meltzer-center/)'s Psychological and Community-Based Services, and to complete a one-year psychology internship training program. In almost all cases this will be an APA- approved pre-doctoral internship program.
