MASTER OF ARTS IN EDUCATION AND HUMAN DEVELOPMENT IN THE FIELD OF REHABILITATION COUNSELING WITH LICENSURE ELIGIBILITY

The philosophy of the rehabilitation counseling program is to help prepare professionals to empower persons with disabilities to help themselves. The program emphasizes the philosophical foundations of rehabilitation; organizational structure of public, nonprofit, and private vocational settings; individual, group, and family counseling theories; behavior and personality theory; human development; multicultural counseling; attitudinal and environmental barriers for the people with disabilities; rehabilitation services; case management; medical and psychosocial aspects of disability; job development and placement; and ethical standards for rehabilitation counselors.

Through intensive coursework, practicum and internship experiences in federal, state, and private settings, and mentoring relationships, students can integrate the critical knowledge and clinical skills needed for professional practice. Graduates of this program are eligible to apply for the Certified Rehabilitation Counselor (CRC) credential, as well as both public and private employment opportunities. While in the program, students participate in GW's mentorship program, which pairs students with program graduates working in a variety of industries. Mentors provide networking and first-hand learning opportunities. Ranked fifth in the nation by U.S. News and World Report and accredited by the Council for Accreditation of Counseling and Related Educational Programs (CACREP), GW's rehabilitation counseling with licensure eligibility program prepares its graduates to be skillful rehabilitation counselors for employment in State/Federal/ Public/Private rehabilitation services, to sit for both the Certified Rehabilitation Counselor exam and the National Certified Counselor exam, and eligibility to pursue the Licensed Professional Counselor (LPC) credential (additional courses can be required to meet state requirements).

ADMISSIONS

Admission deadlines:

Fall – Rolling admissions (January 15 to be considered for merit-based tuition support)

Spring – Rolling admissions (online program only)

Summer – Rolling admissions (online program only)

(Please note: applicants within a 50 mile radius of GW's main campus are only eligible for the main campus program)

Standardized test scores:

Either the GRE general test (institutional code 5246) or the Miller Analogies Test (institutional code 1047) is required. This requirement is waived for applicants who already hold a master's degree conferred by an accredited institution of higher learning.

Recommendations required: Two (2) recommendations

Two (2) recommendations (preferably one from a faculty member and the other from a professional supervisor)

Prior academic records:

Transcripts are required from all colleges and universities attended, whether or not credit was earned, the program was completed, or the credit appears as transfer credit on another transcript. Unofficial transcripts from all colleges and universities attended should be uploaded to your online application. Official transcripts are required only of applicants who are offered admission.

Transcripts from institutions outside the United States must be accompanied by an official transcript evaluation from an accredited independent evaluating agency. Please be sure you request a detailed evaluation that includes all course titles, credit hours, grade-point average (GPA), United States degree equivalency, and date of degree conferral.
