

# EDUCATION SPECIALIST IN THE FIELD OF EDUCATIONAL LEADERSHIP AND ADMINISTRATION

George Washington University's education specialist program (EdS) in educational leadership and administration has garnered national recognition and is designated as a program of distinction by the National Policy Board for Educational Administration (NPBEA). The program is nationally accredited by the Council for the Accreditation of Educator Preparation (CAEP). In addition, it is aligned with and embeds the National Educational Leadership Preparation (NELP) standards in all of its licensure courses and internship experiences.

The program is designed to develop intellectual leaders with a master's in education degree who wish to further their professional skills in facilitating positive change, creating and sustaining a culture of shared leadership and collaboration, ensuring equitable outcomes, and promoting the success and well-being of all school members. The program serves working PreK-12 professional educators in diverse school communities who are interested in PreK-12 school-based or central office leadership positions, central office supervisory positions; increased responsibility in PreK-12 teaching; and/or advanced levels of PreK-12 professional responsibility in public and private schools or similar organizations.

The degree satisfies the credit, coursework, and field experiences required for licensure eligibility as an administrator or principal in the District of Columbia, and the partner states of the interstate compact agreement. Licensure is not automatically granted upon graduation: Candidates must submit a formal application to each state in which they seek a license. It is recommended that GSEHD graduates apply for DC licensure first to ease the process of reciprocity. Following receipt of DC licensure, candidates are eligible for reciprocal certification in more than 40 participating states. ## ADMISSIONS

Admission deadlines: Fall – Rolling admissions

Spring – Rolling admissions

Summer – Rolling admissions

Standardized tests: M.A. Ed.H.D., Post-Master's Certificate, Ed.S.: Standardized tests not required.

Recommendations: Two (2) recommendations from an academic instructor/advisor or someone who can speak of your academic abilities.

**Prior academic records:** Transcripts are required from all colleges and universities attended, whether or not credit was earned, the program was completed, or the credit appears as transfer credit on another transcript. Unofficial transcripts from all colleges and universities attended should be uploaded to your online application. Official transcripts are required only of applicants who are offered admission.

Transcripts from institutions outside the United States must be accompanied by an official transcript evaluation from an accredited independent evaluating agency. Please be sure you request a detailed evaluation that includes all course titles, credit hours, grade-point average (GPA), United States degree equivalency, and date of degree conferral. For a list of acceptable foreign credential evaluation services.

**Statement of purpose:** In your statement of purpose, please address the following in an essay of no more than 750 words (please avoid using bullets and numbers in responding, but demonstrate your writing skills in a coherent essay):

(a) Rationale for seeking a degree in the field of Educational Administration and Administration at GW;

(b) Current knowledge, skills, and leadership experiences that contribute to the candidate's readiness to assume an administrative role as an equity-centered leader;

(c) Vision for serving as a leader who advocates and promotes equity, diversity, inclusion, and transformative practices in their school and communities.

**Additional requirements:** A resumé and an interview with a program advisor are required.

The M.A. Ed.H.D., Post-Master's Certificate, and Ed.S. require a minimum of one year of teaching experience.
