The International Education Program (IEP) empowers students to improve systems of education and to increase access to quality education around the world. In the IEP, students explore the history, culture, development, contemporary concerns, and future trends of schooling and higher education in well-resourced, underresourced, and/or conflict and emergency contexts. Enrolled students learn about traditions and systems of education in other nations and cultures. They also acquire skills and experience relevant to working in these programs. A growing number of internship opportunities, both in the United States and abroad, are made available to our students, who consistently earn prestigious full-time positions after graduation. The international education program boasts highly placed alumni in organizations such as USAID, the World Bank, Save the Children, FHI360, the Institute of International Education, as well as in governments and universities all over the world. International education program faculty regularly draw on local experts and professionals from around the District of Columbia to enhance the curriculum. The program offers expertise in three areas: education and development; global education; and international higher education.
