

# MASTER OF ARTS IN THE FIELD OF PUBLIC POLICY, WOMEN'S, GENDER, AND SEXUALITY STUDIES CONCENTRATION

## OVERVIEW

Along with courses in feminist theory and empirical knowledge about women, gender, and sexuality in the United States and around the world, students take at least four policy courses in the GW Trachtenberg School of Public Policy and Public Administration. Through the program's interdisciplinary curriculum, students learn to analyze policies and structures of power, particularly as they are grounded in gender, race, sexuality, ethnicity, and nationality.

Graduates of the program apply their knowledge and skills to careers in government and as teachers, researchers, lobbyists, public affairs specialists, and advocacy organizations staff members; approximately one-third of program graduates go on to earn doctoral or other professional degrees. Credits earned in this program may be applied toward the doctor of philosophy (PhD) in public policy and public administration degree program.

## ADMISSIONS

### Admission deadlines:

Fall - February 1: Priority consideration for admission and funding; April 1: Guaranteed review for admission and consideration for funding, if available. (Applications for admission will continue to be accepted after April 1, when space remains available in the program.)

### Standardized test scores:

The GRE general is not required, however, if you feel as though submitting scores will strengthen your application, you are welcome to submit them. (Institutional Code: 5246)

The Test of English as a Foreign Language (TOEFL), the academic International English Language Testing System (IELTS), or the PTE Academic is required of all applicants except those who hold a bachelor's, master's, or doctoral degree from a college or university in the United States or from an institution located in a country in which English is *the* official language, provided English was the language of instruction.

Minimum scores for the program are:

- Academic IELTS: an overall band score of 7.0 with no individual score below 6.0; or
- TOEFL: 600 on paper-based or 100 on Internet-based; or
- PTE Academic: 68

**Recommendations required:** Two (2) recommendations. Three (3) recommendations are welcome for those applying for fellowships.

### Prior academic records:

Transcripts are required from all colleges and universities attended, whether or not credit was earned, the program was completed, or the credit appears as transfer credit on another transcript. Unofficial transcripts from all colleges and universities attended must be uploaded to your online application. Official transcripts are required only of applicants who are offered admission.

If transcripts are in a language other than English, English language translations must be provided. The English translation alone should be uploaded into your application.

**Statement of purpose:**

In an essay of 250 – 500 words, state your purpose in undertaking graduate study in your chosen field. Include your academic objectives, research interests, and career plans. Please discuss your readiness to undertake rigorous graduate coursework, including basic courses in quantitative methods and economics. Also discuss your related qualifications, including collegiate, professional, and community activities, and any other substantial accomplishments not already mentioned on the application. If you are applying for a teaching assistantship or fellowship, also describe an teaching experience you have had.

**Writing Sample:**

A 10-15 page writing sample is required.
