

# DOCTOR OF PHILOSOPHY IN THE FIELD OF SOCIAL AND BEHAVIORAL SCIENCES IN PUBLIC HEALTH

The Doctor of Philosophy (PhD) degree in Social and Behavioral Sciences (SBS) creates a cadre of professionals who are uniquely equipped to provide public health expertise and conduct research in the field of SBS. Upon completion of the PhD, these accomplished researchers will be prepared to apply their research and analytic skills to a range of research questions as well as implementation, evaluation, and advocacy needs of various cultural and socioeconomic groups and communities.

The PhD degree program prepares professionals to make significant scholarly contributions to the scientific and evidence base of public health. The PhD program trains strong theoretical, methodological, and practical scholars whose contributions could be as practitioners or academicians. Students are well-trained in a substantive health area with a strong background in social and behavior change theory, study design and evaluation, and statistical methods.
